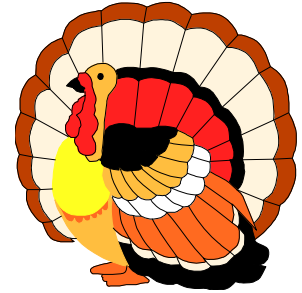
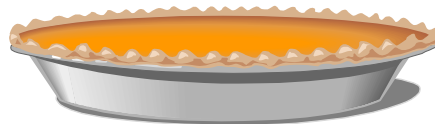
The first Winter Luncheon was held on a beautiful fall with a small, fun crowd of the following Members:
